The details of MACRA can be intimidating, but CareSync is here to help you handle it all.

Can CareSync help me with MACRA?

In so many ways! The spirit of what the Center for Medicare and Medicaid Services (CMS) is trying to accomplish with MACRA is paying providers for the value and quality of the care they provide. Care coordination is at the core of MACRA. The measurement period for 2019 payment adjustments starts on January 1, 2017. Providers who are not prepared to report on quality care measures for their Medicare patients will face a -4% reduction in payment, and the clock is ticking.

Alternatively, providers who understand care coordination, embrace proactive between-visit care, and engage patients to become active participants in their health are well-positioned to succeed.

The latter description? That's how a great CareSync client thinks. When a practice partners with CareSync, they get a trusted partner to help them in the shift to this new care delivery model.

As CMS continues to shift the healthcare industry and Medicare reimbursements from fee-for-service to value-based care, it's time to implement the key provisions of the Medicare Access and CHIP Reauthorization Act of 2015 (MACRA).

Designed to replace the Sustainable Growth Rate formula, MACRA is bipartisan legislation that takes a new approach to reimbursement models. Instead of measuring the value and quality of care providers give using multiple programs, including the Physician Quality Reporting System, the Value Modifier Program, and the Medicare Electronic Health Record (EHR) Incentive Program, MACRA streamlines these programs into one single program: the Quality Payment Program.

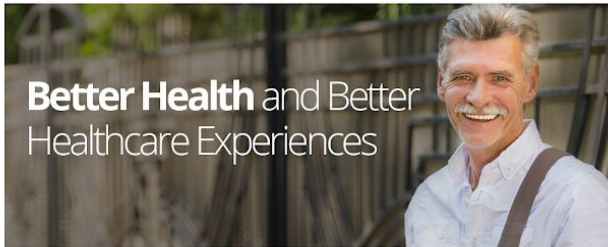

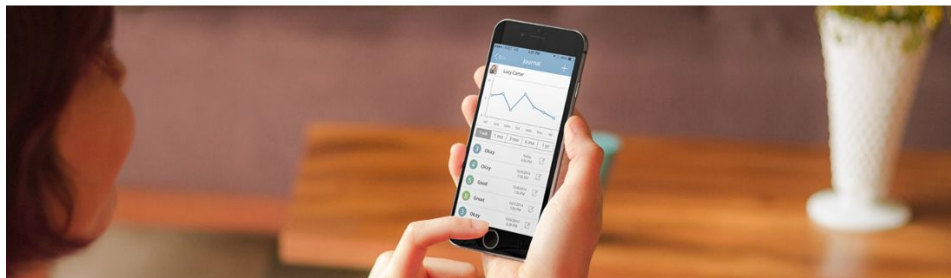

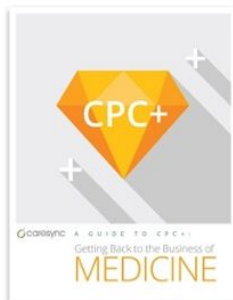
